
the Shreveport Group presents evidence that they can service these areas more satisfactorily than the present Sections can service them. The opinion was, however, that it would be best to defer this for later decision.



Dear Dr. Teal:

Your letter of September 7, 1956, addressed to Mr. Durward Tucker, has been forwarded to us with the petition, requesting approval of the formation of a Shreveport Subsection of the Dallas Section.

This petition has been checked, appears to be in order, and will be submitted to the IRE Executive Committee for approval at their next meeting on September 25, 1956.

We note that action is being deferred for later decision on the possible assignment of additional territory to this Subsection, consisting of Sabine County (Beaumont-Port Arthur Section) and Jackson, Quachita, Caldwell and Winn Parrishes (New Orleans Section) and also McIntosh Parrish. If and when such action is initiated, it will be necessary for the Dallas Section to communicate directly with the Sections concerned for the release of territory to the Dallas Section.

Incidentally, we have thus far been unable to locate McIntosh Parrish in our Atlas here at Headquarters and would appreciate your further advice on its location.

With reference to the transfer of Miller and Lafayette Counties, Arkansas (Little Rock Section) to the Dallas Section and eventual

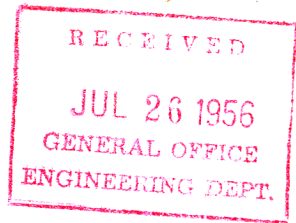
assignment to the Shreveport Subsection, here again, it will be necessary for the Dallas Section to negotiate directly with the Little Rock Section, requesting such transfer.
