Subject: Dissolving Gainesville Florida Section

This is a request to dissolve the Gainesville Florida Section of the Institute of Electrical and Electronics Engineers. The Section has been inactive for the past six years.

In 1989, through the efforts of past and present Section officers, we tried to bring the Section back into full activity. It had been dormant for three years. New officers were elected and we began holding regular meetings. We started a newsletter and started a series of questionnaires and surveys trying to determine what would increase member attendance and participation.

Despite these efforts within the past three years, attendance at meetings has never been more than 15 members out of a total of over 450 members in the Section. Response to the surveys and questionnaires regarding the interests of the members in different activities has been dismal.

For these reasons, as present Section Chairman, I am requesting that the Section be dissolved. Its members could be divided between the Jacksonville Section and the Orlando Section.

We have met with various group trying to encourage volunteers to assume some of the leadership positions within the Section. However, our efforts have been unsuccessful.

Please consider this request and inform me what steps we need to take.

BYLAWS OF THE GAINESVILLE SECTION

Nothing in these Bylaws is to be constructed to be contrary to the IEEE Constitution or Bylaws or the Section Constitution.

Article I - Name and Territory

- Section 1 This organization shall be known as the Gainesville Section of The Institute of Electrical and Electronics Engineers.
- Section 2 The territory of the Gainesville Section as designated by the IEEE Executive Committee includes the following counties, all of which are in the State of Florida:

Alachua	Hamilton	Marion
Bradford	Jefferson	Suwanee
Columbia	Lafayette	Taylor
Dixie	Levy	Union
Gilchrist	Madison	

Article II - Officers

- Section 1 The elected officers of the Section shall be a Chairman, Vicechairman, Secretary, and Treasurer.
- Section 2 The Chairman, Vice-chairman, Secretary, and Treasurer shall be elected to one year terms.
- Section 3 Terms of office will begin on November 1, but in any case the outgoing officers will continue until their successors are duly elected and take office.
- Section 4 Any vacancy occurring during the year may be filled by a majority vote of the Executive Committee.

Article III - Standing Committees

- Section 1 The Standing Committees of the Section will be as follows:
 Publicity, Membership & Transfers, Student Activities,
 Fellow & Awards, Nominating and such other committees as the
 Executive Committee may add.
- Section 2 The Chairmen of the Standing Committees will be appointed by the Chairman with the approval of a majority of the officers and their term will expire the following October 31.
- Section 3 Each Committee Chairman will appoint his committee members with the approval of the Executive Committee, and their terms will expire the following October 31.

Article IV - Management

- Section 1 The management of the Section shall be by the Executive Committee.
- Section 2 A majority of the Executive Committee shall constitute a quorum.
- Section 3 A majority vote of the Executive Committee present shall be necessary in the conduct of its business.
- Section 4 Meetings of the Executive Committee will be called by the Section Chairman or by a request of any three of the Executive Committee members.
- Section 5 The Executive Committee shall consist of the Section Officers & the Junior Past Chairman.

Article V - Nomination and Election of Officers

- Section 1 A Nominating Committee of three members shall be appointed by the Chairman with the approval of the Executive Committee.
- Section 2 The nominations of the Nominating Committee will be announced to the membership and an opportunity given for additional nominations by petition. A petition to be valid must be signed by five or more voting members.
- Section 3 If only one nomination is made for each office, the election will be made at the Annual Meeting. If additional nominations are made, election will be made by ballot mailed to the membership and the vote counted by a committee appointed by the Section Chairman.
- Section 4 The time table for this procedure is as follows:

May - Appointment of Nomination Committee

June 15 - Announcement of Nominations

Sept. 1 - Close nominations by petition

Oct. - Hold Annual Meeting

A ballot, if required, shall be mailed prior to October 1.

Article VI - Business Meetings

Section 1 In order to transact business at a Section Membership Meeting, at least fifteen voting members must be present to constitute a quorum.

Article VII - Finances

Section 1 All expenditures of Section Funds must be approved by the Section Executive Committee.

- Section 2 Without prior authorization of the IEEE Headquarters Executive Committee, Section Funds can only be used for normal operations of the Section such as payment for meeting halls, equipment used at a meeting, mailing and promotional expenses.
- Section 3 The Treasurer shall be authorized to draw funds as approved by the Executive Committee.

Article VIII - Amendments

- Section 1 Proposals for amendments may originate in the Section Executive Committee or by a petition of twenty-five or more voting members.
- Section 2 Amendments to or revocation of these Bylaws shall be made in accordance with the Section Constitution.
